Payment Terms: Full payment is due with your registration form for all markets. If you would like to pay by check, please make checks payable to Fast Forward and mail to: 1399 N. Cuyamaca Street, El Cajon CA 92020. Your registration is not confirmed until your payment has been received.

Cancellations: All cancellations must be submitted in writing no later than 60 days before the event to receive a full refund, minus a \$45 handling fee. There will be no refunds for cancellations made within 60 days of the event.

Insurance: Exhibitor and exhibitor display contractor(s) shall maintain Comprehensive General Liability Insurance and Personal Injury coverage for all Exhibitor's activities at the event, all at Exhibitor's sole cost and expense.
